



CITY OF MISSION HILLS APPLICATION FOR FIREWORKS PERMIT

CONDITIONS:

1. All fireworks exhibitions shall be conducted on Country Club property and may occur only on weekends or holidays.
2. All exhibitions not related to the Fourth of July must be completed by 10:30 p.m., and shall last no longer than twenty (20) minutes. Fourth of July exhibitions may take place up to four (4) days before or two (2) days after the Fourth of July.
3. Application for Fireworks Permit must be filed with City Hall at least thirty (30) days before display, with the following:
 - a. \$50 permit fee,
 - b. copy of the Alcohol, Tobacco, Firearms and Explosives permit for possession of Division 1.3G fireworks for each person who will be handling or discharging the fireworks,
 - c. diagram or sketch of the grounds on which the exhibition is to be held showing the point at which the fireworks are to be discharged, the location of all buildings, improvements and public streets or thoroughfares within two hundred (200) yards and the lines behind which the public will be restrained, and
 - d. certificate of insurance which evidences that applicant has public liability insurance applicable to the exhibition with minimum limits of one million dollars (\$1,000,000) for any one occurrence, and one million dollars (\$1,000,000) for property damage.
4. All fireworks exhibitions shall be conducted in accordance with the provisions of NFPA 1123 Code for Fireworks Display 2010 Edition.
